And Whereas the intellectual property owned by Flonetwork Inc. and subject to this Security Agreement is identified in Schedules A and B attached hereto;


And Whereas Flonetwork Inc. entered into a Master Loan and Security Agreement with Transamerica Commercial Finance Corporation Canada;
