NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, NAMD does hereby assign unto Integris Metals, Inc., a New York corporation, all right, title and interest in and to such Mark, together with the goodwill of the business symbolized by the Mark, and the right to sue for past infringement of the mark, and NAMD agrees to execute and deliver such additional documents as may be reasonably required to evidence assignment of such Mark to Integris Metals, Inc. This Assignment is subject to all terms, conditions and limitations set forth in the Merger Agreement.

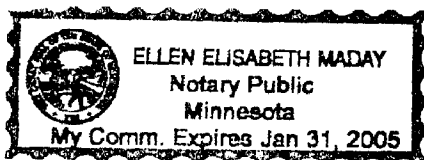
