RESOLVED, that Haas Publishing Companies, Inc. merge, and it hereby does merge into itself Databook, Inc. and assumes all its obligations;

FURTHER RESOLVED, that the merger shall be effective upon the date of filing with the Secretary of State of Georgia; and

FURTHER RESOLVED, that the proper officer of this corporation be and he or she is hereby directed to make and execute a Plan of Merger setting forth a copy of the resolutions to merge said Databook, Inc. and assume its liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State and to do all acts and things whatsoever, whether within or without the State of Georgia, which may be necessary or proper to effect said merger.
