**THIRD AMENDMENT TO THE ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Section 16-10a-1001 et seq. Of the Utah Revised Business Corporation Act, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

SECOND: The following amendment of the Articles of Incorporation was adopted by the sole voting common stock shareholder and the sole director of the corporation in the manner prescribed by the Utah Revised Business Corporation act:

Article I is amended in its entirety to read as follows:


The name of this Corporation is **Sorenson Technologies, Inc.**





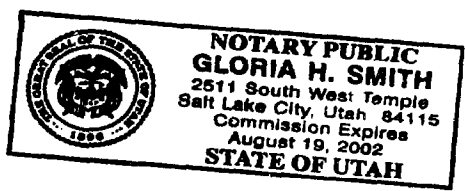
