Pursuant to the provisions of Section 30-1-1006 of the Idaho Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Pursuant to Article 1 of the corporation's Articles of Incorporation, the name of the corporation is Preco, Inc.

SECOND: Article 1 of the Articles of Incorporation of said corporation is amended to state as follows:

Article 1

The name of this corporation is SCP Global Technologies, Inc.

THIRD: The date of the adoption of the amendment by the shareholders of the corporation was the 29th day of September, 2000, in the manner prescribed by the Act.
