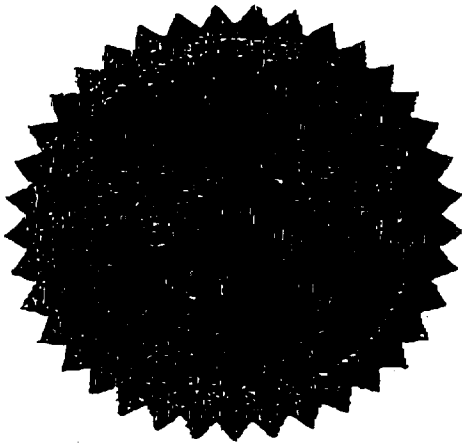

The undersigned, Andre O. Schwager, hereby certifies that:

ONE: He is the duly elected and acting President of CustomerCast, Inc., a California corporation.

TWO: Article I of the Fourth Amended and Restated Articles of Incorporation of this corporation is hereby amended to read as follows:

"ARTICLE I

The name of this corporation is SatMetrix Systems, Inc."

THREE: The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors of said corporation.

FOUR: The foregoing amendment was approved by the holders of the requisite number of shares of said corporation in accordance with Sections 902 and 903 of the California General Corporation Law. The total number of outstanding shares of each class entitled to vote with respect to the foregoing amendment was 8,366,914 shares of Common Stock, 8,049,336 shares of Series A Preferred Stock, 3,533,367 shares of Series B Preferred Stock and 2,040,377 shares of Series C Preferred Stock. The number of shares voting in favor of the foregoing amendment equaled or exceeded the vote required, such required vote being a majority of the outstanding shares of Common Stock and a majority of the outstanding shares of Preferred Stock, each voting separately as a class.
