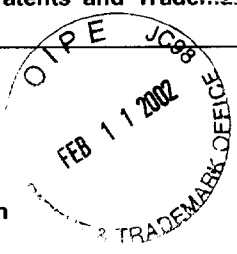

**SECOND:** The certificate of incorporation of the Corporation is hereby amended by striking out Article First thereof and by substituting in lieu of said Article the following new Article:


**FIRST:** The name of the corporation is: CEYONIQ, Inc.
