ASSIGNMENT

WHEREAS, Boyt Limited Partnership (hereinafter BLP), a limited partnership organized under the laws of Delaware, having a principal office and place of business at 509 Hamilton Avenue, Iowa Falls, Iowa 50126, had become owner by Assignment of the Trademarks listed on Attachment A;

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and said Assignor, by these presents does sell, assign and transfer unto the said Assignee, its successors, assigns and legal representatives, the said trademarks listed on Attachment A, together with the right to assert the trademarks listed on Attachment A and to collect for all past and future claims of damages occasioned by reason of any past or future acts of infringement that have or may occur and to collect all income, damages and payments now and hereafter due or payable under or with respect to these trademarks, and for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.
