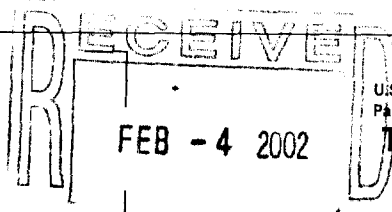

## TRADEMARK ASSIGNMENT

WHEREAS, HARCROS CHEMICALS Inc., a Delaware corporation ("Seller"), has agreed to transfer all of its right, title and interest in and to the trademarks listed in Exhibit TM attached hereto ("Trademark Rights") to Purchaser (as defined below);

WHEREAS, HCI ACQUISITIONS Inc., a Kansas corporation ("Purchaser"), desires to acquire Seller's interest in and to such Trademark Rights pursuant to an Asset Purchase Agreement dated as of October 22, 2001 by and among Purchaser, Seller and Seller's parent corporation (the "Asset Purchase Agreement").

NOW, THEREFORE, in consideration of the agreements and obligations recited in the Asset Purchase Agreement and other good and valuable consideration received from Purchaser, the receipt and sufficiency of which is hereby acknowledged, Seller hereby sells, assigns, transfers, and sets over unto Purchaser, its successors and assigns, all right, title, and interest which Seller has, in and to the Trademark Rights, together with that portion of the good will of the business of Seller connected with the use of the Trademark Rights, and all causes of action, past, present, and future for infringement of the Trademark Rights.

Seller further covenants and agrees that it will, at any time upon request and at Purchaser's cost, execute, and deliver any and all documents that may be reasonably requested by Purchaser to perfect the title to the Trademark Rights in Purchaser, its successors and assigns, and that it will, at any time upon request and at Purchaser's cost, communicate to Purchaser, its successors and assigns such facts relating to the Trademark Rights or the history thereof as may be known to it.

This Trademark Assignment is being delivered pursuant to the Asset Purchase Agreement and shall be construed consistently therewith. This Trademark Assignment is not intended to, and does not, in any manner enlarge, diminish or modify the rights and obligations of the parties to the Asset Purchase Agreement. To the extent that any provision of this Trademark Assignment conflicts or is inconsistent with the terms of the Asset Purchase Agreement, the terms of the Asset Purchase Agreement shall govern.
