**CERTIFICATE OF AMENDMENT

AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
APCOA, INC.**

Pursuant to Section 242 of the General Corporation Law of the State of Delaware, APCOA, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY:

**FIRST:** That by unanimous written consent of the members of the Board of Directors of the Corporation, filed with the minutes of the Board, resolutions were duly adopted setting forth a proposed amendment of the Amended and Restated Certificate of Incorporation of the Corporation and declaring said amendment to be advisable. The resolution setting forth the proposed amendment is as follows:

**RESOLVED,** that the Board of Directors determines that it is advisable that the Corporation's Amended and Restated Certificate of Incorporation be amended, upon stockholder approval, and in accordance with Section 242 of the General Corporation Law of the State of Delaware, to change the corporate name of the Corporation to "APCOA/Standard Parking, Inc."

**SECOND:** That in lieu of a meeting and vote of stockholders, the stockholders of the Corporation have given unanimous written consent to said amendment and said amendment was duly adopted in accordance with the applicable provisions of Sections 242 and 228 of the General Corporation Law of the State of Delaware.

**THIRD:** Therefore, in accordance with the foregoing, Article I of the Amended and Restated Certificate of Incorporation of the Corporation is amended to read in its entirety as follows:

Article I


The name of the corporation (which is hereinafter referred to as the "Corporation") is:

APCOA/Standard Parking, Inc.

**FOURTH:** That the capital of the Corporation shall not be reduced under or by reason of said amendment.
