**ASSIGNMENT AND RELEASE OF INTEREST IN
TRADEMARKS AS SECURITY INTEREST**

AGREEMENT made as of this 4th day of December, 2001, by and between Credit Lyonnais, New York Branch, as assigned by Bankers Trust Company (the "Lender"), and Dalloz Safety, Inc., a Delaware corporation, Dalloz Fall Protection Investment In., a Delaware corporation, as successor by assignment to certain trademarks of Dalloz Safety, Inc., and Dalloz Investment, Inc., a Delaware corporation, as successor by assignment to certain trademarks of Dalloz Safety, Inc. (collectively, the "Assignors").

W I T N E S S E T H :

WHEREAS, pursuant to that certain Security Agreement dated as of October 24, 1989 (the "Security Agreement"), between Lender and Assignors, Assignors assigned to Lender all of rights, in certain trademarks then existing as listed on the attached Exhibit A (the "Trademarks") as security for the obligations set forth in the Security Agreement; and

WHEREAS, Assignors have satisfied said obligations and Lender has agreed to release its security interest in the Trademarks and reassign all right, title and interest in and to all of the Trademarks to Assignors.


NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, Lender and Assignors hereby agree as follows:

1. Lender hereby assigns and transfers to Assignors, without recourse, its entire right, title and interest in and to all of the Trademarks, including the goodwill associated therewith, described in the Security Agreement.
2. Lender hereby releases its mortgage and security interest in the Trademarks, and agrees to deliver, at Assignors' sole cost and expense, any and all UCC-3 Termination Statements, together with any and all other release documents which may be necessary to effect this Agreement
3. Assignors and Lender hereby acknowledge and agree that the Security Agreement is terminated as of the date of this Agreement.


