and (ii) all right, title and interest of ASSIGNOR in and to the mark TOPICORT in the United States of America.

TO HAVE AND TO HOLD unto ASSIGNEE, its successors and assigns forever, together with the good will attached thereto related to the products sold to ASSIGNEE pursuant to the PURCHASE AGREEMENT in the United States of America. This ASSIGNMENT (i) is executed by and shall be binding upon ASSIGNOR and its successors and assigns, (ii) shall inure to the benefit of ASSIGNEE and its successors and assigns, (iii) shall be governed by and construed in accordance with the laws of Delaware without regard to conflict of laws principles thereof, and (iv) shall be subject to the provisions of the PURCHASE AGREEMENT.
