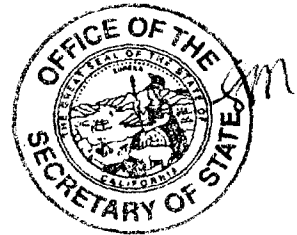

1. They are the duly elected and acting President and Secretary, respectively, of **INTREON CORPORATION**, a California corporation.

2. Article I of the Articles of Incorporation of this corporation is amended and restated to read in full as follows:

“The name of the Corporation is **MOXI DIGITAL INC.** (the “Corporation” or the “Company”).”

3. The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors.


4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation is **193,087,913** shares of Common Stock and 70,418,820 shares of the Series Preferred. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%) of the outstanding shares of Common Stock and the Series Preferred, voting as a single class.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
