WHEREAS, Assignee desires to acquire Assignor’s right, title and interest in and to the Marks.



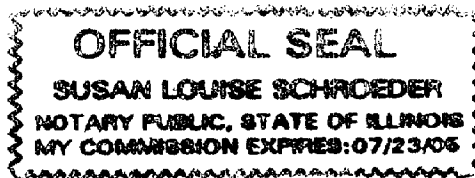
