ASSIGNMENT

WHEREAS, Westwood-Squibb Pharmaceuticals, Inc., a Delaware corporation, having a business address at 100 Forest Avenue, Buffalo, New York 14213 ("Assignor") filed an application on December 15, 1998 to register the mark SOLAGE based on a bona fide intent to use it in connection with topical pharmaceutical preparations for the treatment of hyperpigmentation, Application Serial No. 75/607,704; and

WHEREAS, on December 31, 2001, Galderma S.A., a Swiss corporation, having an address at Zugerstrasse 8, CH-6330 Cham, Switzerland ("Assignee") acquired the worldwide portion of the business of the Assignor relating to topical preparations for the treatment of hyperpigmentation, including the worldwide rights to the Assignor's patents, marketing, and the SOLAGE trademark; and

WHEREAS, Assignee is desirous of having an assignment for recording in the United States Patent and Trademark Office to reflect its ownership of U.S. Application Serial No. 75/607,704 - SOLAGE.

Now, therefore, good and valuable consideration being extant, the Assignor has assigned and hereby assigns, effective as of December 31, 2001, all of its rights, title and interest in and to the mark SOLAGE, U.S. Application Serial No. 75/607,704, and the goodwill of the business symbolized thereby.

Assignor further assigns to Assignee all right to sue for, to receive and to hold damages and profits accruing from past infringement of the SOLAGE mark in the United States or elsewhere.

Assignor warrants that there are no licenses, encumbrances or other agreements, either written, oral or implied, relating to the SOLAGE mark and that Assignor believes that it had good and valid title to the mark to assign to Assignee on December 31, 2001.

Assignor further warrants that, upon the request of Assignee, it will execute all papers, make all rightful oaths, testify on behalf of Assignee and do all other lawful acts necessary to carry out the intent of this agreement, as well as to provide such other material, information, and/or assistance as Assignee may consider necessary, provided that Assignee shall reimburse Assignor its reasonable, direct out-of-pocket expenses in providing such material information and/or assistance.
