TRADEMARK ASSIGNMENT

WHEREAS, The Arnold Palmer Golf Company, a Tennessee corporation (the "Assignor"), owns the trademarks shown on the attached Schedule A (the "Marks");

WHEREAS, pursuant to that Asset Purchase Agreement of even date herewith by and among the Assignor and A.M.A. International Group, Inc., a Michigan corporation, with its principal offices at 4700 S. Lapeer Road, Orion Township, Michigan 48359 ("Assignee"), Assignor has agreed to sell to Assignee, and Assignee has agreed to purchase, all of Assignor's right, title and interest in and to the Marks, the registrations related thereto, and all goodwill associated with and symbolized by the Marks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee all of Assignor's right, title and interest in and to the Marks, together with the goodwill associated with and symbolized by the Marks, and all of Assignor's right, title and interest in and to the registrations listed on Schedule A, along with any right to any foreign registrations of the Marks and any right owned by Assignor to sue and recover damages past, present and future for infringements or dilutions of the Marks.

The Assignor agrees to execute any instruments and perform any acts which may be necessary to carry this Assignment into full effect.
