
TRADEMARK ASSIGNMENT



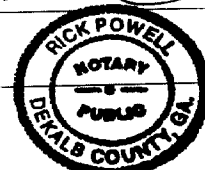
