# ASSIGNMENT

LFI hereby transfers, conveys, and assigns to WARD all of LFI's rights, titles, and interests in and to all trademarks and service marks, and registrations therefor, connected with the CLUB SHRED property and all goodwill arising from, associated with, and symbolized by such marks, including without limitation the marks and registrations listed below at Schedule B and the goodwill connected therewith.

LFI hereby transfers, conveys, and assigns to WARD all of LFI's rights, titles, and interests in and to all ideas, concepts, trade secrets, and trade dresses comprised in or associated with the CLUB SHRED property.

LFI hereby transfers, conveys, and assigns to WARD all of LFI's rights, titles, and interests, including without limitation possessory rights, in and to all artwork, story boards, manuscripts, and other materials in LFI's possession describing or depicting the CLUB SHRED property, including without limitation all such materials describing, depicting, containing or generating reproductions of the above-mentioned works of authorship, marks, and trade dresses, but excluding T-shirt inventory of the same.

Notwithstanding the above conveyances, excluded from this assignment are two LIFEFORMS designs, i.e., design number 004 "Club Shred Sharks" and design number 016 "Club Shred Grizzly," which, though incorporating the words "Club Shred," are essentially part of the LIFEFORMS line of designs, and LFI retains all rights to exploit those two designs without obligation to WARD.


