**FIRST AMENDED AND RESTATED**

**LICENSE, MAINTENANCE AND DISTRIBUTION AGREEMENT**

THIS FIRST AMENDED AND RESTATED LICENSE, MAINTENANCE AND DISTRIBUTION AGREEMENT is entered as of this 28th day of May, 1999 ("Effective Date"), by and between Reuters Limited, a company organized under the laws of England and Wales, with offices at 85 Fleet Street, London EC4P 4AJ, United Kingdom ("Reuters") and TIBCO Finance Technology, Inc., a Delaware corporation, with offices at 3375 Hillview Avenue, Palo Alto, California 94304 ("TFT"), on the one hand, and TIBCO Software, Inc., a Delaware corporation, with offices at 3165 Porter Drive, Palo Alto, CA 94304 ("TSI"), on the other.

2.8 Trademark License.

(a) The Reuters Parties hereby assign and transfer to TSI all of their respective right, title and interest in and to the Transferred TIB-Related Marks and all goodwill associated therewith, subject to a perpetual, royalty-free, irrevocable, worldwide right and license in favor of the Reuters Parties and their Affiliates to use Transferred TIB-Related Marks in connection with the marketing, use, sale and distribution of any of the Reuters Parties' and their Affiliates' respective products or the provision by the Reuters Parties or their Affiliates of any services. At TSI's sole expense, the Reuters Parties shall perform such acts and execute such documents as are reasonably required to perfect the foregoing assignment and obtain and enforce trademark service mark and other similar rights in the Transferred TIB-Related Marks.


