**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF ORGANIZATION  
OF  
JAMESON HOSPITALITY, LLC**

**ARTICLE I**

The name of the Company is Jameson Hospitality, LLC.

**ARTICLE II**

The Articles of Organization of the Company were filed in the Office of the Secretary of State of Georgia on April 3, 1996. On May 7, 1998, the Articles of Organization were amended by changing the name of the Company from Jameson Development Company, LLC to Jameson Hospitality, LLC.

**ARTICLE III**

Article I of the Articles of Organization of the Company is deleted in its entirety, and the following new Article I is substituted in its place:
