ASSIGNMENT

WHEREAS, the parties wish to acknowledge this assignment and make it of record in the United States Patent and Trademark Office and the United States Copyright Office.



LCTC agrees to fully cooperate with JCI and provide JCI any and all documentation required to perfect such assignment, including, but not limited to, providing JCI the copyright registration numbers for any and all of the LCTC Copyrights.
