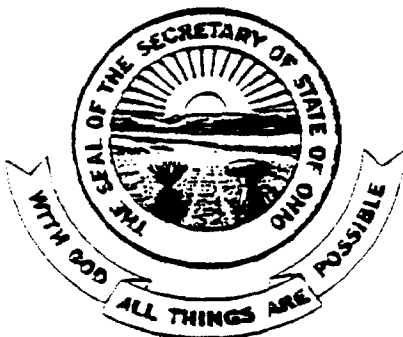

"FIRST:

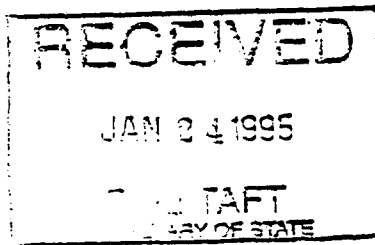


