

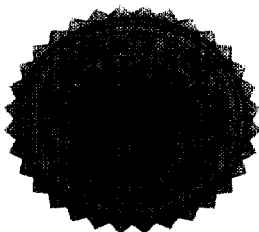


'First: The name of the Corporation (hereinafter the "Corporation") is Home Juice Corp.
