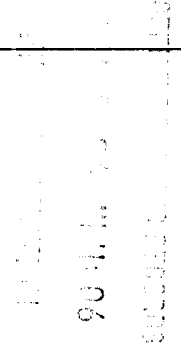



TRADEMARK ASSIGNMENT


