ASSIGNMENT OF TRADEMARK

This assignment is made by and between Sound ID Corporation, formerly known as RxSound Corporation, a California corporation having its principal place of business at 801 Welch Road, Palo Alto, California (hereinafter "Assignor") and GN ReSound North America Corporation, a California corporation having its principal place of business at 220 Saginaw Drive, Redwood City, California (hereinafter "Assignee").

WHEREAS, Assignor has adopted and has used the mark RXSOUND (the "Mark") in connection with hearing-related goods and services;

WHEREAS, on February 23, 1995, Assignor filed with the U.S. Patent and Trademark Office ("PTO") an application to register on the Principal Register the mark RXSOUND (Stylized) "for hearing aid kits comprising hearing aids, ear lenses for amplifying selected frequencies, hearing aid face plates, batteries and cleaning supplies" in International Class 10 (serial number 74/637,648), which matured to registration on December 19, 2000 (the "Registration");

WHEREAS, Assignor represents and warrants to Assignee that Assignor has not previously transferred, remised and/or released to any other person or entity or encumbered in any manner any ownership or other interest Assignor has or may have in the Mark or the Registration; and

WHEREAS, Assignor and Assignee have entered into a Settlement Agreement pursuant to which Assignor has agreed to assign the Registration and the Mark to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee all right, title and interest in and to the Registration and the Mark, together with the goodwill of the business symbolized by the Registration and the Mark, and any and all claims, demands, and causes of action for infringement of the Mark, past, present, and future, and all of the proceeds from the foregoing.

Assignor further agrees to execute such further documents as may be necessary (1) to complete or evidence this assignment; (2) to record the assignment with the PTO; and (3) to ensure that the Registration is issued in Assignee's name.
