

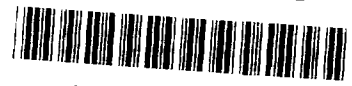



ASSIGNMENT OF TRADEMARKS

AGREEMENT made this 30th day of July, 2000 by and between ON Technology Corporation, a Delaware corporation with a principal place of business at 880 Winter Street, Building Four, Waltham, Massachusetts 02451 ("Assignor"), and Meeting Maker, Inc., a corporation organized under the laws of the Cayman Islands, with a principal place of business at 880 Winter Street, Building Four, Waltham, Massachusetts 02451 ("Assignee").

WHEREAS, Assignor has applied for and/or obtained the trademark or domain name registrations relating to the trademarks and domain names listed on Schedule A hereto (collectively, the "Trademarks"); and

3. Cooperation by Assignor. Upon Assignee's request, Assignor and its officers, representatives and successors shall perform all acts reasonably necessary to ensure the full and complete enjoyment by Assignee of all right, title and interest in and to the Trademarks, including without limitation the execution, delivery, filing and recording, at Assignor's expense, of such further assignments, certificates, applications, instruments and other documents as may be requested by Assignee.


