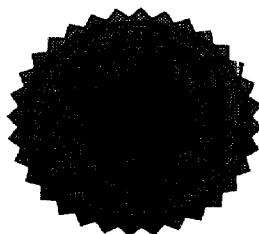

**CERTIFICATE OF AMENDMENT
OF
CERTIFICATE OF INCORPORATION**

Crossbow Acquisitions, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"),

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said Corporation, by the unanimous written consent of its members, filed with the minutes of the Board, adopted resolutions proposing and declaring advisable the following amendments to the Certificate of Incorporation of said Corporation:

RESOLVED, That the Certificate of Incorporation of Crossbow Acquisitions, Inc. be amended by changing Article "FIRST:" thereof so that, as amended, said Article shall be and read as follows:

FIRST: The name of the Corporation is Aerie Network Services, Inc. (the "Corporation").

FURTHER RESOLVED, That the Certificate of Incorporation of Crossbow Acquisitions, Inc. be amended by changing Article "THIRD:" thereof so that, as amended, said Article shall be and read as follows:

THIRD: The purpose of this Corporation is to form a telephone corporation for profit, to engage in the telephone and telecommunications business; to construct, own, control, operate, and manage telephone and telecommunications lines and equipment, to provide telephone and telecommunications services to others; to transmit intelligence and messages by telephone or telegraph; to appropriate private land as is necessary to construct facilities to carry out such purposes; and to engage in any lawful act or activity for which a corporation may be organized under the Delaware General Corporation Law.

SECOND: That in lieu of a meeting and vote of stockholders, the stockholders have given unanimous written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.
