RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE of Trademark Security Interest ("Release") is executed and delivered this 16th day of January, 2002 by FLEET BOSTON FINANCIAL CORPORATION to RJM MANUFACTURING CO.

BACKGROUND

A. On October 13, 1993, RJM Manufacturing, Inc., a Delaware corporation executed and delivered to Barclays Business Credit, Inc. a certain Trademark Security Agreement ("Security Agreement") which was recorded in the United States Patent and Trademark Office at Reel No. 1048 / Frame No. 0388.

B. Shawmut Capital Corporation purchased certain assets of Barclays Business Credit, Inc., including without limitation, all of Assignor's right, title and interest in the Security Agreement, which assignment was recorded in the United States Patent and Trademark Office at Reel 1330 / Frame 408;

C. Fleet Boston Financial Corporation acquired certain assets of Shawmut Capital Corporation including the "Security Agreement".

D. RJM has satisfied all of its financial obligations secured by the Security Agreement.

NOW, THEREFORE with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:
