TRADEMARK ASSIGNMENT

Now therefore, in consideration of the parties' mutual covenants and undertakings, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, April does hereby confirm that April did assign, convey and transfer to Beazer under the Purchase Agreement all right, title and interest in and to the Trademarks together with the goodwill of the business symbolized by them, including all common law rights in and to the Trademarks.
