RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Trademark Security Interest Release is granted and conveyed as of January 10, 2002 by Constellation Venture Capital II, L.P. ("Constellation"), in favor of Widevine Technologies, Inc., a Delaware corporation ("Widevine").

WHEREAS, on July 30, 2001, Constellation recorded an Assignment of Security Interest (Trademarks) at the United States Patent and Trademark Office, reflecting that Widevine and Constellation had entered into a Security Agreement dated as of May 8, 2001, under which Widevine granted to Constellation a security interest in the trademarks listed on the attached Schedule A, any applications for federal registration or federal registrations therefor, and the goodwill associated therewith (the "Marks").


WHEREAS, Widevine has satisfied all of its outstanding obligations under the Security Agreement, and the parties seek to make a record of Constellation's releases and reassignments to Widevine of any and all of their security interests in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Constellation hereby confirms that it has (1) released, discharged, and relinquished, as of January 10, 2002, its security interests in the Marks, and (2) reassigns to Widevine, as of January 10, 2002, any and all right, title, and interest that Constellation may have had in the Marks, including the goodwill associated with the Marks. Constellation specifically acknowledges that the security interests are no longer effective, and that Constellation does not own any rights to or have any ownership interest in the Marks.

IN WITNESS WHEREOF, Constellation has caused this Release of Security Interest in Trademarks to be duly executed in its name by its proper corporate officer thereunto, duly authorized on the date set forth beneath its signature below.
