ASSIGNMENT

This document, effective January 11, 2002, confirms the assignment of the trademark Laker (that is the subject of U.S. Trademark Registration 999,055) from Fishing Spirit, Inc., a Wisconsin corporation having an office in Spirit Lake, Iowa ("Fishing Spirit") to Jadico, Inc., a Missouri corporation having an office in Camdenon, Missouri ("Jadico") on the following terms:

1. Fishing Spirit owns the Laker trademark (including the registration) and the goodwill associated therewith, and hereby assigns the trademark, registration, and goodwill to Jadico.
2. Jadico has paid Fishing Spirit \$10,000 for said trademark, registration and goodwill and the other covenants contained in this document, and Fishing Spirit acknowledges receipt of said \$10,000.
3. Jadico hereby grants to Fishing Spirit an exclusive, perpetual license to use the Laker trademark on fishing rods and reels, and Fishing Spirit agrees to continue to exercise the level of quality control on such goods as it has in the past.
4. Jadico shall be responsible for all expenses involved in obtaining and filing any documents necessary to record its ownership of the trademark and/or registration. Fishing Spirit shall cooperate with Jadico in signing any such documents necessary to record said ownership.
5. The sale of the trademark, registration, and goodwill shall be free of any liens or encumbrances, and Fishing Spirit agrees to clear any such liens or encumbrances within a reasonable amount of time from the date of this document.
6. Jadico shall be responsible for all expenses involved in maintaining the Laker registration and in obtaining additional Laker registrations, if any.
7. A facsimile copy of this document shall be as enforceable as the original.

The parties therefore recognize that the terms set forth above accurately reflects the transaction concerning the transfer of the trademark, registration and goodwill by signing as indicated below:
