NUNC PRO TUNC ASSIGNMENT OF TRADEMARKS

WHEREAS, Craftstone, Inc., a Tennessee corporation having an address of P.O. Box 23524, Chattanooga, Tennessee 37422 (hereinafter "Assignor"), or its predecessors in interest, adopted and used the trademarks CRAFTSTONE and CRAFTSTONE THE SOLID CHOICE and Design, which are registered in the U.S. Patent and Trademark Office (Reg. Nos. 1,996,542, issued August 27, 1996, and 2,420,450, issued January 16, 2001, respectively), for use in connection with countertops and sinks (hereinafter referred to as the "Marks"), and

WHEREAS, pursuant to that certain asset purchase agreement dated on or about June 1, 1999 (the "Asset Purchase Agreement"), by and between Assignor and Webco, Inc., ~~a Tennessee corporation~~ ^{a Tennessee corporation} having an address of 125 Industrial Park Drive, Soddy-Daisy, Tennessee 37379 (hereinafter "Assignee"), Assignor agreed to sell, assign and transfer certain of its assets to Assignee including the Marks, and

WHEREAS, it was intended that Assignee acquire all right, title and interest in and to said Marks and the registrations therefor as of June 1, 1999, which assignment Assignor is desirous of confirming and making of record, and

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor confirms that it intended and has sold, assigned, transferred and conveyed, and does hereby sell, assign, transfer and convey to Assignee, nunc pro tunc, as of June 1, 1999 all right, title, and interest in and to the Marks, including the above-identified registrations and any and all other registrations or applications therefor, and the right to recover damages for past acts of infringement of said Marks, together with all of Assignor's goodwill of the business symbolized by the Marks. Assignor consents to and requests recordation of this transfer and further authorizes and requests that all official documents and communications relating to said Marks or the registration(s) and/or application(s) therefor issue and deliver to Assignee, its attorneys, agents, successors or assigns.
