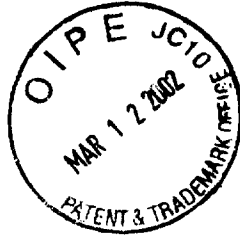

RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST made and entered into this 1st day of November, 1999, by PNC BANK, NATIONAL ASSOCIATION ("PNC"), as Agent for the Banks, in favor of NOVACARE, INC., a Delaware corporation, and each Subsidiary of NovaCare identified on Schedule A or B hereto (collectively "NOVACARE").

WHEREAS, NOVACARE, PNC and the Banks and the Guarantors set forth therein are parties to a certain Credit Agreement dated May 27, 1994, under which the Banks extended loans to NOVACARE and a certain Patent, Trademark and Copyright Security Agreement dated March 24, 1999, and recorded in the United States Patent and Trademark Office on April 12, 1999 at Reel 9922, Frame 0704 and at Reel 1889, Frame 0180, under which NOVACARE granted PNC, in its capacity as Agent for the Banks, a security interest in certain patents, patent applications, and trademark registrations including those listed in Schedule I; and

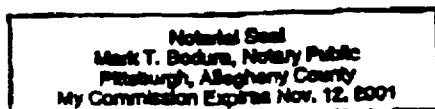
