RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This Release of Security Interests in Trademarks is made as of February 14, 2002 by BANK ONE, WISCONSIN, as collateral agent for the Benefited Parties (as defined in the Subsidiary Guarantor Security Agreement referred to below) (the "Secured Party"), with its principal place of business at 111 East Wisconsin Avenue, Milwaukee, Wisconsin 53202, regarding KLEIN BICYCLE CORPORATION (the "Company"), with its principal place of business located at 118 Klein Road, Chehalis, Washington 98532, and with reference to the following facts:

WHEREAS, the Company and the Secured Party had previously entered into a Subsidiary Guarantor Security Agreement dated as of July 26, 1999 (the "Subsidiary Guarantor Security Agreement"), for the purpose of securing certain obligations of the Company to the Secured Party; and

WHEREAS, the Company has previously executed an Intercompany Security Agreement dated as of July 26, 1999 (the "Intercompany Security Agreement"), in favor of Trek Bicycle Corporation, who assigned all of its right, title and interest under the Intercompany Security Agreement to Trek Corporation, who assigned all of its right, title and interest under the Intercompany Security Agreement to the Secured Party; and

WHEREAS, the Secured Party desires to release its security interest in the personal property of the Company which was granted to the Secured Party pursuant to the Subsidiary Guarantor Security Agreement and the Intercompany Security Agreement (by virtue of the subsequent assignment thereof);

NOW, THEREFORE, for valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Secured Party releases any and all security interests held by it in and to any and all of the trademarks, service marks, applications therefore and associated goodwill therein, owned by the Company, including without limitation those trademarks listed on Exhibit A attached hereto, and in and to all proceeds and benefits thereof.
