



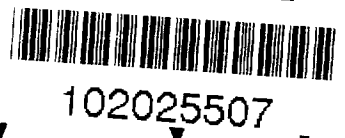

TRADEMARK ASSIGNMENT

This Agreement is made on the 5 day of March, 2002, between L. Lawrence Products, Inc., a Pennsylvania corporation, with an address at 445 Vair Road, Huntington Valley, Pennsylvania 19006 ("Assignor") and Stephen Est. 1985, Inc., a Pennsylvania corporation, with an address at P.O. WHEREAS, Assignor is the owner of the trademark and trademark registration in the form more fully described in Exhibit 1 hereto (the "Mark");

WHEREAS, Assignor and Assignee have executed that certain purchase agreement dated the 5 day of March, 2002 (the "Purchase Agreement");



NOW, THEREFORE, for the consideration set forth in the PURCHASE AGREEMENT, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, Assignor hereby sells, transfers, assigns and sets over unto Assignee, its successors and assigns, all of Assignor's entire right, title and interest in and to the Mark, in the United States of America, together with the goodwill associated therewith and symbolized by the Mark, all common law rights related thereto, all rights of renewal and extension, and the right to recover for damages and profits for past infringements thereof.

Assignor agrees to execute and deliver at the request of the Assignee all papers, instruments, and assignments, and to perform any other reasonable acts Assignee may request in order to vest all of Assignor's right, title, and interest in and to the Mark in Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.


