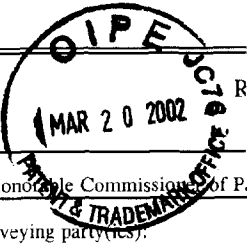

RELEASE OF LIEN

This Release of Lien is effective as of February 28, 2002 ("Effective Date").

WHEREAS, GOLDEN TECHNOLOGIES COMPANY, INC., a Colorado corporation ("Debtor") entered into an Assignment and Security Agreement on February 1, 2000, ("Security Agreement") with BANK OF AMERICA, N.A., a national banking association, as administrative agent for the Lenders ("Administrative Agent"), pursuant to which the Debtor granted a security interest in certain Collateral (as defined in the Security Agreement) including concerning the intellectual property listed in Annex A ("Intellectual Property Collateral") (capitalized terms not otherwise defined herein shall have the meanings set forth in the Security Agreement);

WHEREAS, the Security Agreement was recorded in the U.S. Patent and Trademark Office on February 15, 2000, at Reel 002037, Frame 0133 with respect to the Trademarks;

WHEREAS, the Security Agreement was recorded in the U.S. Patent and Trademark Office on February 15, 2000, at Reel 010609, Frame 0655 with respect to the Patents; and

WHEREAS, Administrative Agent proposes to release its lien on the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

As of the Effective Date, Administrative Agent, on behalf of the Lenders, hereby releases any and all security interests the Lenders have in the Collateral, including without limitation, the Intellectual Property Collateral, and the Security Agreement is hereby terminated and rendered null, void and without any further force or effect.
