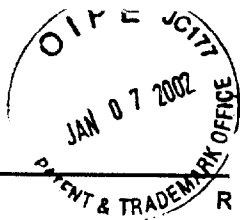

TRADEMARK ASSIGNMENT AGREEMENT

TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement"), dated as of September __, 2001, by and between Eagle Family Foods, Inc. ("Assignor"), and Cadbury Beverages Delaware, Inc. ("Assignee") (Assignor and Assignee may collectively be referred to as the "Parties").

WHEREAS, Assignor is engaged, in part, in the business of developing, manufacturing, marketing, distributing and selling shelf-stable juice sold under the ReaLemon/ReaLime and related brand names (which businesses are hereinafter referred to as the "Business");

WHEREAS, Assignor, Eagle Family Foods Holdings, Inc., Assignee and Mott's Inc. ("Mott's") have entered into an Asset Purchase Agreement, dated as of August 13, 2001, (the "Purchase Agreement") relating to the purchase by Assignee and Mott's from Assignor of substantially all of the assets and certain liabilities of Assignor principally related to the Business (collectively, the "Assets");

WHEREAS, Assignor owns various trademarks and service marks used, or held for use, principally in connection with the Business, including, but not limited to, (a) those listed on the attached Schedule 1, (b) any registrations or pending applications for registration for the foregoing, whether in, or outside of, the United States, and (c) the goodwill appurtenant thereto (collectively, the "Marks"); and

WHEREAS, Assignor desires to transfer and assign all of its right, title and interest in and to the Marks to Assignee, and Assignee wishes to acquire all rights, title, and interest in and to the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor hereby assigns to Assignee all of its right, title, and interest in and to the Marks. All rights and privileges, including the right to sue for and receive all damages from past infringements of the Marks shall be held and enjoyed by Assignee, its successors and assigns.
