## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "**Agreement**"), between Taylor Corporation, a Minnesota corporation located at 1725 Roe Crest Drive, North Mankato, Minnesota 56002 ("**Assignor**"), and Current USA, Inc., a Minnesota corporation located at 1725 Roe Crest Drive, North Mankato, Minnesota 56002 ("**Company**"), is executed on April 2, 2002.

### RECITALS
