ASSIGNMENT OF TRADEMARK

This Assignment of Trademark is made and effective as of the 13 day of March, 2002, by and between Richard E. Capps d/b/a Info Board Display Co., having a business address of P. O. Box 1924, Seguin, Texas 78155-8924 (hereinafter "CAPPS") and Deflecto Corporation, a Delaware corporation, having a principal place of business at 7035 East 86th Street, Indianapolis, IN 46250 ("DEFLECTO").

WHEREAS:

- (A) CAPPS is the owner of record of United States Federal Trademark Registration No. 2,471,750, issued July 24, 2001, for the mark, DOCUPOCKET; (hereinafter collectively referred to as the "Trademark"); and
(B) CAPPS has agreed with DEFLECTO to transfer of all right, title and interest in and to the Trademark to DEFLECTO together with all of the goodwill of the business and in the goods in respect of the Trademark.

NOW, THEREFORE,

In consideration of the sum of three thousand five hundred dollars (\$3,500.00) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by CAPPS, CAPPS hereby sells, conveys, assigns, transfers and delivers to DEFLECTO, its successors and assigns, all of the right, title and interest CAPPS has in, to and under the Trademark, including all of the common law rights and all of the goodwill of the business associated therewith, and all applications thereon and arising therefrom, United States and foreign, including all extensions, renewals and abandoned applications thereof and all registrations issued and obtained therefor and thereon, United States and foreign, and further including all rights to sue for and to recover injunctive and other relief for future infringements thereof and to otherwise stand in the place of CAPPS in all matters related thereto. CAPPS further covenants that DEFLECTO will, upon request, be provided promptly with all pertinent facts and documents relating to the Trademark as may be known and accessible to CAPPS and that CAPPS will reasonably, upon request, promptly execute and deliver to DEFLECTO or its legal representatives any and all papers, instruments, or affidavits required to carry out and record this transfer and assignment of the Trademark to DEFLECTO.

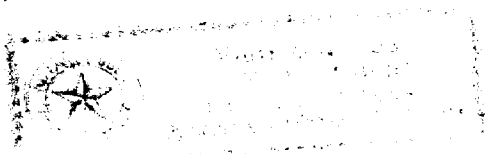
