WHEREAS, Assignor has entered into an Asset Purchase Agreement, dated as of November 14, 2001 (the "Purchase Agreement"), between Assignor and RGTL NEVADA LIMITED, a corporation organized under the laws of the State of Nevada ("Assignee"), pursuant to which, among other things, and subject to the terms and conditions set forth therein, Assignor has agreed to sell, and Assignee has agreed to purchase, all of Assignor's right, title and interest in and to the U.S. trademark registrations and applications listed on Schedule A attached hereto (collectively, the "Trademarks"), and the goodwill associated with the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, convey, transfer and deliver to Assignee all of Assignor's right, title and interest in and to the Trademarks together with the goodwill associated with the Trademarks (including, without limitation, all proceeds thereof, all rights of action and recovery for past, present and future infringements thereof and all rights to secure renewals and extensions thereof), and all rights therein provided by international conventions and treaties, the same to be held and enjoyed by Assignee, for its own use and on behalf of its successors and permitted assigns, as fully and entirely as the same would have been held and enjoyed by Assignor, had this sale, assignment, conveyance, transfer and delivery not been made.

Assignor further agrees to perform such other lawful acts and to execute such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Trademarks in the United States Patent and Trademark Office.

This Assignment is being executed and delivered pursuant and subject to the Purchase Agreement. Nothing in this Assignment shall, or shall be deemed to, defeat, limit, alter, impair, enhance or enlarge any right, obligation, claim or remedy created by the Purchase Agreement. In the event of any conflict between this Assignment and the Purchase Agreement, the Purchase Agreement shall control. Without limiting the foregoing, this Agreement is subject to the third and fourth sentences of Section 12.18 of the Purchase Agreement.
