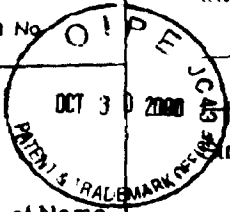

This is a resubmission of an assignment document for the above trademark from Top Star Distribution Group Inc. to Rex Inc.






