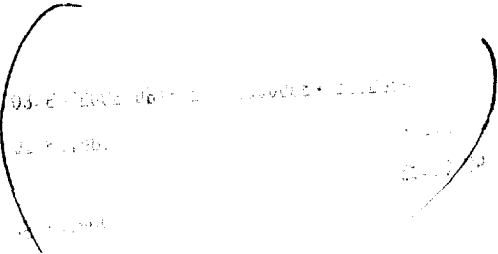

### Description of Collateral

DEBTOR: Build Systems, LLC  
SECURED PARTY: BDC Preston Properties One Limited Partnership

As collateral security for all present and future obligations of Debtor to Secured Party, Debtor hereby grants to Secured Party a security interest in all the following types of property of Debtor, wherever located, now owned or hereafter acquired, including but not limited to all items on the list attached hereto and:
