**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of March 27, 2002, from JPMorgan Chase Bank, as successor to The Chase Manhattan Bank, as Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to NatureSmart LLC, a Colorado limited liability company with its principal place of business located at 1500 East 128th Avenue, Thornton, Colorado 80241.

WITNESSETH:

WHEREAS, pursuant to the Assumption Agreement, dated as of May 29, 2001, made by the Additional Grantors (as defined therein) in favor of the Agent (the "Collateral Agreement"), a security interest (the "Security Interest") was granted by the Additional Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Assumption Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 27, 2001 at Reel 002357 and Frame 0440;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions: The term "Trademark Collateral," as used herein, shall mean all of the Additional Grantors' right, title and interest of every kind and nature as of the date hereof in the trademark listed on Schedule A hereto.
2. Release of Security Interest: The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
3. Further Assurances: The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
