ASSIGNMENT OF TRADEMARKS

This Assignment is made as of April 1, 2001 between SYBRON CHEMICAL HOLDINGS, INC., a Delaware corporation ("Assignor"), and BAYER CORPORATION, an Indiana corporation ("Assignee").

Preamble

Assignor is the owner of certain United States Trademarks (the "Trademarks") used or useful in connection with, or otherwise relating to, Assignor's textiles chemicals business (the "Business").
