
CONFIRMATORY ASSIGNMENT - USA

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each ASSIGNOR, did and hereby does assign, transfer and convey unto ASSIGNEE all of ASSIGNOR's right, title and interest in and to the respective MARKS, together with any and all registrations thereof (encompassing said underlying applications) and the goodwill of the business connected with the use of and symbolized by the respective MARKS, including without limitation, the right to petition, sue or otherwise seek and recover damages, profits and any other remedy (monetary, injunctive, declaratory or other), for any past, present or future infringement, dilution, conversion or misappropriation of, or other injury, offense, violation, breach of duty or wrong relating to the respective MARKS, or any license, agreement, contract or other matter relating thereto.


