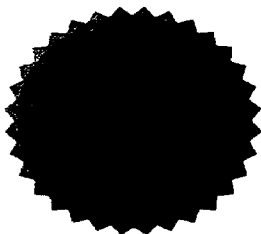

Pursuant to the provisions of Section 252(c) of the Delaware General Corporation Law (the "DGCL"), GeoTrust Merger Corporation, a Delaware corporation and the surviving corporation ("GeoTrust-Delaware"), in the merger of GeoTrust, Inc., an Oregon corporation ("GeoTrust-Oregon"), with and into GeoTrust-Delaware (the "Merger"), does hereby certify that:

1. The name and state of incorporation of each of the constituent corporations in the Merger are as follows:

2. An agreement and plan of merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 252(c) of the DGCL.

3. The name of the surviving corporation in the Merger is GeoTrust Merger Corporation, a Delaware corporation.

4. Effective as of the Merger, Article I of the Certificate of Incorporation of GeoTrust-Delaware shall be amended to read as follows:

Article I

The name of the corporation is GeoTrust, Inc.


5. The executed agreement and plan of merger is on file at the office of the surviving corporation located at 115 SW Ash, Suite 520, Portland, Oregon 97204.

6. A copy of the agreement and plan of merger will be furnished on request and without cost to any stockholder of any constituent corporation.

7. The authorized capital stock of GeoTrust-Oregon is 650,000,000 shares, consisting of 375,000,000 shares of common stock, without par value, and 275,000,000 shares of preferred stock, without par value.
