**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Termination") is executed and delivered this 13 day of March, 2002 by First Union Commercial Corporation ("FUCC"), as Agent, to Arch Aluminum & Glass Co., Inc. ("Arch").

**BACKGROUND**

A. On May 19, 1998, Arch, a Florida corporation executed and delivered to FUCC a certain Security Agreement ("Security Agreement").

B. Pursuant to the Security Agreement, inter alia, Arch granted a security interest in each of the trademarks AMARLITE, U.S. Trademark Registration No. 543,004, and OBLIQUE WALL, U.S. Trademark Registration No. 1,273,310, to FUCC (the "Grant").

C. A Notice of Grant of Security Interest in Trademarks was recorded in the United States Patent and Trademark Office at Reel No. 1734/Frame No. 0524 to record the Grant.

D. Arch has satisfied all of its obligations secured by the Security Agreement.

NOW, THEREFORE with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. FUCC terminates and releases all of its right, title and interest in each of the trademarks AMARLITE, U.S. Trademark Registration No. 543,004, and OBLIQUE WALL, U.S. Trademark Registration No. 1,273,310.

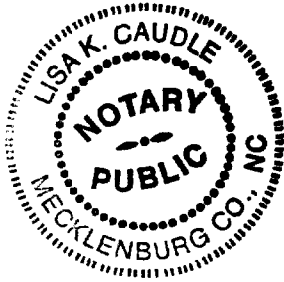
