TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is hereby entered into and effective the 20th day of June, 2001, by and between **ANCHOR GLASS CONTAINER CORPORATION**, A Delaware corporation, having an office at 4343 Anchor Plaza Parkway, 1 Anchor Plaza, Tampa, Florida 33634 (the "ASSIGNOR"), and **HEARTHMARK, INC. d/b/a ALLTRISTA CONSUMER PRODUCTS COMPANY**, an Indiana corporation having an office at 345 High Street, Suite 201, Muncie, Indiana 47305-2398 (the "ASSIGNEE").

WHEREAS, ASSIGNOR, Alltrista Corporation and ASIGNEE are parties to that certain Trademark License Agreement dated October 1, 1997 (the "License Agreement"); and

WHEREAS, contemporaneously with the execution of this Trademark Assignment, the parties to the License Agreement intend to terminate all of their respective rights and obligations under the License Agreement as provided for in the Trademark License Termination Agreement attached hereto and marked Exhibit A; and

WHEREAS, ASSIGNOR, subject to the License Agreement is the owner of the entire right, title and interest in and to the following trademark registration that has been issued by the U.S. Patent and Trademark Office (hereinafter referred to as the "Mark"):

WHEREAS, ASSIGNEE is desirous of acquiring the Mark, as well as all other common law rights, world-wide rights and other applications and registrations for the Mark owned by ASSIGNOR;

NOW, THEREFORE, for goods and valuable consideration, the receipt and sufficiency of which are acknowledged, ASSIGNOR hereby assigns to ASSIGNEE all right, title and interest in and to the Mark, together with the goodwill of the business associated with out symbolized by the Mark and all common law rights, world-wide rights and other applications or registrations for the Mark owned by ASSIGNOR, and including the right to sue and collect damages for any past infringements of the Mark. ASSIGNOR shall also fully cooperate with ASSIGNEE in recording this Assignment, including promptly executing any and all documents necessary to recor5d and fully effectuate this Assignment.

ASSIGNOR hereby represents and warrants that: (a) upon the execution and delivery of the Trademark License Termination Agreement, it is the sole owner of all

right, title and interest in and to the Mark, free and clear of all liens and encumbrances, and that no assignment, encumbrance, or security interest has been or will be made or entered into which would conflict with this assignment; (b) the undersigned has sufficient authority to execute this Agreement on behalf of ASSIGNOR; and (c) the Mark does not infringe any valid rights of any third party, and that to the best of ASSIGNEE'S knowledge, information and belief, there are no actions for infringement against ASSIGNOR with respect to the Mark anywhere in the world.

ASSIGNOR agrees to indemnify, defend, or otherwise hold harmless ASSIGNEE against all costs, expenses and losses (including reasonable attorney's fees) incurred through claims of third parties based on a breach by ASSIGNOR of any representation or warranty made in this Assignment.

ASSIGNOR and ASSIGNEE acknowledge and agree that this Assignment may be executed in counterparts, and each fully executed counterpart shall be deemed an original, and all of which together shall constitute one and the same instrument.
