UNDER SECTION 904 OF THE BUSINESS CORPORATION LAW

We, the undersigned, Conrad A. Conrad and Richard Winkler, being respectively the vice president and the assistant secretary of MEDO MANUFACTURING CORP., and Conrad A. Conrad and Richard Winkler, being respectively the vice president and the assistant secretary of MEDO INDUSTRIES, INC., hereby certify:

- 1. (a) The name of each constituent corporation is as follows: MEDO MANUFACTURING CORP., a corporation organized and existing under the laws of the State of Maryland, and MEDO INDUSTRIES, INC., f/k/a AUTO AID MFG. CORP., a corporation organized and existing under the laws of the State of New York.
- (b) The name of the surviving corporation is MEDO INDUSTRIES, INC., and following the merger its name shall be MEDO INDUSTRIES, INC.

2. As to each constituent corporation, the designation and number of outstanding shares of each class and series and the voting rights thereof are as follows:

The total number of shares of stock of all classes which said MEDO INDUSTRIES, INC. has authority to issue is two hundred (200) shares, divided into two classes as follows: one hundred eighty (180) shares of no par value common stock (Class A) having full voting rights. The holders of such Class A stock are entitled to vote for the election of directors or in any corporate proceeding or upon any matter or question whatever pertaining to the corporation; and twenty (20) shares of no par value common stock (Class B). The holders of such Class B stock are not entitled to vote for the election of directors or in any corporate proceeding or upon any matter or question whatever pertaining to the corporation unless otherwise required by law, but have all other rights and privileges enjoyed by holders of Class A stock.

The total number of shares of stock of all classes which said MEDO MANUFACTURING CORP. has authority to issue is two hundred (200) shares, divided into two classes as follows: one hundred eighty (180) shares of no par value common stock (Class A) having full voting rights. The holders of such Class A stock are entitled to vote for the election of directors or in

any corporate proceeding or upon any matter or question whatever pertaining to the corporation; and twenty (20) shares of no par value common stock (Class B). The holders of such Class B stock are not entitled to vote for the election of directors or in any corporate proceeding or upon any matter or question whatever pertaining to the corporation unless otherwise required by law, but have all other rights and privileges enjoyed by holders of Class A stock.

3. The Certificate of Incorporation of MEDO INDUSTRIES, INC., which is the surviving corporation, as in effect on the date of the merger provided for in this certificate of merger, shall continue in full force and effect as the Certificate of Incorporation of the corporation surviving this merger.



The certificate of incorporation of MEDO INDUSTRIES, INC., a corporation organized and existing under the laws of the state of New York, was filed on the 20th day of September, 1972, with the New York Department of State. The articles of incorporation of MEDO MANUFACTURING CORP., a corporation organized and existing under the laws of the State of Maryland, were filed on the 30th day of June, 1986, with the Maryland Secretary of State. No application for authority to do business in the state of New York has been filed by MEDO MANUFACTURING CORP.


5. The merger was adopted by each constituent corporation in the following manner:
