STANDARD TOOLS ACQUISITION CORP., a Delaware corporation (the "Corporation"), does hereby certify as follows:

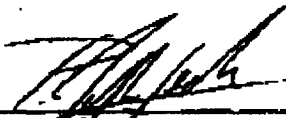
1. The current name of the Corporation is "STANDARD TOOLS ACQUISITION CORP."
